ELECTIONS AND TRANSITIONS

If your organization is on a calendar year election cycle, then November typically means a process that can include many steps; applications, nominations, interviews, slating, and finally elections. Once elections are over it can be difficult to resist the urge to ride off into the sunset, but transitions play a critical role in the future success of your organization and in ensuring your own legacy as a leader. Transitioning responsibilities following an election process is the last act of a leader in relation to their role. Make sure you're spending time thoughtfully planning transitions and you can get your successor started off on the right foot.

Some quick reminders post-election:

- Update your FSCL Advisor with the name and contact information of the new President, make sure your council leaders know too!
- Together, with the new president walk them through re-registering your organization on BoilerLink.
 - This is also a great time to reach out to your Faculty/Staff Advisor and have the new President introduce themselves.
 - Remember to tell them about the SAO required President and Treasurer training!
- New presidents should complete the [FERPA training on Webcert](#) shortly after elected so that they are able to access semester grade reports.

HOUSED ORGANIZATION CORNER

PREPARING FOR WINTER WEATHER

Freeze claims each year cost hundreds of thousands of dollars. Losses predominantly occur the break periods when there is limited daily oversight of the facility further exacerbating the costs.

Reduce risks by doing the following:

- Leave the heat on (no less than 60 degrees) to maintain the temperature in the building.
- Ensure all windows and doors are closed properly and locked to prevent theft.
- Identify an individual in charge of checking the house over the holiday breaks, they should:
 - Make sure the pilot light on the furnace stays lit
 - Conduct walk throughs of the building and around the property
 - Make certain the house is secure, there hasn't been a loss and that the heat is working



It is important to also be aware of your outside property. To help reduce the risk of injuries of members, guests, or other people just passing by your house, make sure that snow is removed and ice is treated in a timely fashion.

HOUSE LIVE-IN REQUIREMENTS

The opportunity to live-in as a member of an FSCCL organization represents a core component of the experience for our housed organizations. The ability to experience membership alongside your peers in a shared living environment has the potential to create life long memories and provide that "home away from home" so many college students are looking for.



We understand that the facility also plays a role in organization finances. Recently, a trend of requiring a three year contract has received some push back from students and their parents. FSCCL supports and encourages the development of policies and procedures around a three-year live-in requirement. Setting expectations around live-in requirements, is essential to an honest and transparent recruitment process and satisfaction as an active member.

A live-in requirement provides flexibility for members to engage in academic pursuits outside of the Greater Lafayette community, while still communicating expectations for members. In the local area most apartments rent on a 12 month lease and Residence Halls utilize an annual contract period. We encourage organizations to research options that provide for the financial future of their facility while still retaining members through practices that allow for flexibility.
